MINUTES

NOTE: Due to the COVID-19 outbreak, this meeting was held virtually on Zoom. Attendees were able to participate on the phone or online.

Welcome/Introductions (B. Herrington)

B. Herrington opened the meeting at 9:35 am. She welcomed all SICC members and attendees.

Review and Approval of Minutes (B. Herrington)

Minutes from the July 30, 2021, meeting was reviewed by everyone (motion by R. Blakeney; second by J. Parker). Minutes were then approved as written.

SICC Business (B. Herrington)

The following business items were discussed:

B. Herrington reported that the committee is looking for additional people to serve in leadership roles. S. Callender reported that we have been trying to recruit and finalize the list. The committee has gotten five new parents that will be added.

SICC Committee Reports (B. Herrington)

The following updates were provided on the work of the committees:

- **Personnel Preparation Committee:** J. Parker, Chair, reported that they have participants registered for the first credential for the state of MS and Early Intervention. They have 30 participants registered to start out in the credential. Jim Lesko, MS's ECPC Technical Assistant continues to assist and help provide guidance.
- **Public Awareness Committee:** L. Rolison, Chair, was not available. M. Richardson reported that they are still in the process of completing a draft of the report that is waiting on data. Once completed, the draft report will be sent to the MSDH Communications Office for final preparation. The completed draft will be presented to the SICC hopefully by the next meeting.
- **Transition Committee:** C. Henington, Chair, reported that they are still trying to recruit members for the committee. They are still in the process of working on a pilot to put together a resource book for families as they go through the transition from Part C to Part B.
- **Recruitment/Retention Ad Hoc Committee:** R. Blakeney, Chair, had no updates to report. S. Callender reported that they are still conducting a rate study. We have created a list of CPT codes of possible Early Intervention services. We shared it with our third-party billing company and their billing experts. They provided us back a list of the rates. The person we've been working with through the Division of Medicaid is Jennifer Wentworth. It's a really

big task and very challenging. Once we get that worked out, we will be sharing that with everyone.

Program Updates

The following updates were provided by the Program personnel:

- **Personnel Updates:** S. Callender reported that we have all of the regional positions filled: Denise Booth, Northern Region and Gary Logan Central Region. LaSondra Jenkins will be leaving us and going to CPS. Michelle Masterson will be retiring at the end of the month. Stephanie Bailey left earlier this month. We were approved for promotion and pay increases for our existing staff and expanded the number of service coordinators and coaches we have available to hire. We will be posting a large number of vacancies.
- **SSIP Stakeholder Meeting:** S. Callender reported that the Stakeholder meeting will be held on November 16, 2021, at the Jackson Medical Mall and there are forty slots available for in-person. The meeting will be held as a combination of both in-person and virtual.
- **Training Updates:** M. Richardson reported that the service coordinators, program coordinators, and regional coordinators have completed their IGDI trainings. We also had train and trainer in which we trained our coaches and QTA's. Our next two major trainings will be coming up: RBI trainings and additional training with J. Parker.
- **Monitoring Update:** M. Richardson reported that she has finished the reports and each district should be getting their reports in today. She will not be sharing the results at this time until each district and program have seen their own reports. There will be another round of monitoring coming around November or December timeframe.

Set Targets for Result Indicators: M. Richardson presented data showing set targets. The targets have to be set for the next five years from 2020-2025. In February 2022 she will be reporting data that happened between July 1, 2020 – June 30, 2021. We have our result indicators and the compliance indicators have always been at one hundred percent. We have to set result indicators for Indicator II which are settings, child outcomes, family outcomes and for child find.
